- As of the publishing of this premium, we expect the trial to go on as described. All trial decisions will be in accordance with New Jersey state, local guidelines and best practices in place at the time of the trial.
- **Closing Date: Wednesday, October 21, 2020**
- Entry is limited.
- In the event that the trial needs to be canceled because of virus restrictions, we will notify all exhibitors via email **no later than the closing date**. (Checks will not be cashed.) After closing, the refund policy as detailed in this premium will remain in effect.
- Bayshore Companion Dog Club is making every effort to supply a safe trial environment. However, exhibitors are entering the trial at their own risk.

Other things you can expect on trial days:

- Everyone entering the building will be required to sign a release (see next page).
- There will be **no** indoor crating for exhibitors. Please come prepared to work from your car.
- Spectators will not be allowed in the building. Traffic flow in and out of the building will be clearly marked.
- Masks will be required to enter the building. Exhibitors are expected to bring masks, they will not be supplied. The expectation is that you will be required to wear a mask when in the ring.
- Parking: Leave some “social space” between cars when parking, expect to work from your car. RV Parking will not be available.
- Social distancing will remain in effect.
- Paper course maps will not be available. Course maps will be displayed in several places. Come prepared to photograph the map for your personal use.
- Check-in and armband pick-up area will be clearly marked.
- Food will not be available onsite. Plan on bringing your own lunch, water, drinks, ice, etc.

Important Entry Notes:

All Obedience and Rally classes will be run in **jump height order** from Small to Tall. **Your jump height MUST be included on the entry form for all classes that require a jump.**

UDX/RAE/RACH Entries: Please check the box on the entry form for UDX/RAE/RACH. Dogs entered in this class will be entered in both Utility B/Open B, Excellent B/Advanced B or Excellent B/Advanced B/Master. Once the limit has been reached in any class, entries will be returned in their entirety. UDX/RAE/RACH entries are eligible for the waiting list, but if "all" classes do not become available by closing, the multiple-class UDX/RAE/RACH entry will be returned and the next eligible waitlisted person will receive the slot.

A VERY LIMITED waiting list will be established to fill openings created by entries that are withdrawn prior to the event closing date. See details in premium.

Telegraph, telephone and unsigned entries cannot be accepted. Entries not on an official AKC entry form and photocopies of entry forms without agreement and rules section of the official AKC entry form are NOT ACCEPTABLE. If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made. An AKC Recording Fee of \$.50 first entry only and an AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. An AKC Recording Fee of \$3.50 will be required for each first entry, \$3.00 for each additional entry in any Licensed or Member Club Rally Trial. NOTICE TO EXHIBITORS

- All judging will be indoors.
- Transfers will be permitted in accordance with Obedience Regulations, Chapter 1, Section 16. and Rally Regulations, Chapter 1, Section 15. The request for a transfer must be in writing and presented to the Trial Secretary at least 30 minutes prior to the start of the trial. Due to judging limits, there is no guarantee that all requested transfers can be honored.
- A wait-list will be established in order to fill openings created by entries that are withdrawn prior to the event closing day.
- Rally ring size will be 40 x 50.
- Obedience and Rally classes will run in jump height order from "Small to Tall" both days.
- Your jump height must be included on the entry form for all classes that require a jump.
- **Crating:** There will be no indoor crating for exhibitors. Please come prepared to work from your car. (*Exceptions are Trial Chair, Trial Secretary and All-Day Volunteers, with express permission of the Trial Chair.*)
- Free admission / Free parking. No food vendors will be at this event.
- **REFUND POLICY:**
Bitches in season are not permitted to compete in obedience trials. The club will refund all but \$10.00 of the entry fee for bitches in season that are unable to compete for that reason. Refund requests must be accompanied by a dated, signed letter on official business letterhead from your veterinarian stating the reason that your dog cannot compete. The Trial Secretary must be notified no later than one half hour prior to the start of the first class in the trial.

E-mails, phone calls and non-letterhead notes will not be considered. There will be no refund for injury or illness after entries close.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Show Committee deems the exhibitor to be in violation of this requirement. No dogs under 4 months of age on show grounds. There will be no smoking in the building. Please dispose of all trash in the proper manner.
- The judge is not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called. All dogs present must be held on a leash, or confined to a crate except when being judged.
- Exhibitors should follow their veterinarians recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. From NJ Turnpike exit 7A: Take I-195 East to Route 526. Make a Right on Route 526 to Main Street. Make a Right on Main St. to Route 539. Make a Left on Route 539 to Arneytown-Hornerstown Road. Make a Right on Arneytown-Hornerstown Road.

From NJ Turnpike exit 7: Take Route 206 North to Route 528 (Crosswicks Road). Make a Right on Route 528; travel approximately 6 miles, Pass through 1 roundabout. and stay straight DO NOT TURN RIGHT . Stay straight to go onto Arneytown Chesterfield Rd/County Hwy-664, (Road is now Route 664). Follow Route 664; it will turn right; On the corner you note a house with windmills.
