<u>Late Entries after September 14th will be charged the Day of fee of \$30 perentry.</u>

<u>Pay of entries as space allows</u> with secretary permission.

ABOUT RETURNED CHECKS: DRMarketing will not return checks for entries that are not accepted, or entries cancelled by the competitor before the closing date and before the check has been deposited. We shred all unused checks. All entries must be accompanied with payment to be valid. A returned check is not a valid entry. A Returned Check for insufficient funds will be charged an additional \$30 fee.

This will be a CONCURRRENT Trial using a BLOCK schedule. NO RUN ORDER! A time block will be assigned.

An email explaining the process will be sent out prior to the trial.

Fast CAT events are open to all dogs at least 12 months of age that are registered with the AKC, dogs granted a Purebred Alternative Listing (PAL) number, dogs with limited or Conditional Registration and dogs enrolled in the Canine Partners program. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate. If your mix breed dog needs an AKC Canine Partner number a form and information is available on page 5 in this Premium. Dogs may only run once per test.

<u>Hours</u>

Grounds will be available a half hour prior to trial hours. Trial hours are usually either 7:30 or 8:00AM until 3:30PM or until all runs are completed. It is also the responsibility of each entrant to be ready with catcher and releaser when their dog is called to the line.

<u>Collar Rules:</u> Dogs may run without a collar or wear any type of collar except choker collars, electronic training collars or head collar. Collars should be snug. Hanging tags pose a safety concern and it is suggested that tags be secured to the collar with tape. Dogs may run muzzled if desired. Clips or rubber bands may be used to keep long hair from falling across the dog's field of vision.

Check in & Inspection.

Check in/Inspection starts 15 minutes prior to the beginning of the trial and each time block or throughout the event. Every dog must pass through inspection before each run. Dogs who miss their time block will be skipped. If you do not check in within one hour prior to the end of the trial closing, we will assume you are absent. No refunds for absent dogs. At inspection, all dogs will be examined for disqualifications. Bitches known to be in season are not to be brought to the test. At inspection, bitches in season, lame and unfit dogs will be excused with entry refunded minus a \$3.00 service fee per run.

Refunds!

You may pull out of the trial prior to closing date/time for a refund minus a \$3.00 service fee per entry run per dog. There will be no refund after closing for any reason, including injury or illness to human or dog unless the limit has been met and there is a waitlist participant to take your spot.

Prizes

A flat blue ribbon for a passing qualifying run.

Rosettes for completing titles BCAT, DCAT or FCAT, as available.

Please notify the Trial Secretary in advance if you anticipate completing a title by writing in on the bottom of the entry form.

What is the Fast CAT?

- 1. Fast CAT is a timed straight 100-yard dash for dogs.
- 2. Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into a catch pen. The course is completely fenced, and dogs are run individually.
- 3. Dogs are timed when they complete the 100-yard dash. The time is converted to Miles Per Hour (MPH).
- 4. Based on the dog's size at the withers a handicap is applied. and points are earned:
 - 18" or greater = Handicap is 1.0
 - 12" up to less than 18" = Handicap is 1.5.
 - Under 12" = Handicap is 2.0.

5. FORMULA: MPH X HANDICAP = POINTS

6. Titles are earned at specific point levels.

BCAT = 150 points, DCAT = 500 points, FCAT = 1,000 points

FCAT# = Each additional 500 points

*ACCORDING TO AKC RULES; Handlers are not permitted to run with a dog during an official run. Handlers are not to entice the dog through the course with anything other than the lure during its official run. NO mechanical devices including whistles, horns, bull horns, etc. Or toys including the waving of objects to lure the dog to the finish line. You MAY CHEER and use the dog's name only.

Trial Site Directions

From North: GSP (Garden State Pkwy) South, Go South on Rt. 9 towards Freehold. Take exit for Rt. 18 South (left exit). Follow Rt. 18 South to exit for Rt. 537 West (towards Freehold). Before second light on Rt. 537 West, follow sign bearing to the right jug handle to make a left on Kozloski Rd. Show site is approximately 0.5 miles on the right.

From Northeast: Rt. 537 West to Kozloski Road. Before Kozloski, follow sign bearing to the right jug handle to make a left on Kozloski Rd. Show site is approximately 0.5 miles on the right.

From East: Take Rt. 33 West to Kozloski. Take a left up the ramp to get onto Kozloski Blvd heading north. Follow to site on left approximately 0.6 miles to site. If exiting GSP at NJ-33 heading W towards Freehold you can: 1. Bear right onto Business 33 past the intersection with Fairfield Road and then follow direction above or 2. Take Highway 33 and exit northbound onto Halls Mill Rd., which changes name to Kozloski Rd at the Howell/Freehold border and then follow directions above. From West: Take Rt. 33 East to Halls Mill Rd Exit (This is past the Rt. 33, Rt. 537, and Rt. 9 exits). Take Halls Mill Rd. North (it turns into Kozloski) to site on left.



Be sure to bring plenty of shade and water for your dog! Please Park in designated area & walk up to the sign in table. Please have your catcher with you so that you may go directly to the line to run while your catcher goes directly to the catch pen area.

Trial Information

- Dogs should be warmed up before and cooled down after running.
- ALL DOGS RUN AT OWNER'S SOLE RISK
- All AKC rules regarding sportsmanship and conduct apply.
- This is a rain-or-shine outdoor event. Please plan accordingly. The show grounds are not completely fenced. The FAST CAT course will be fenced.
- On site porta johns are available.
- Dogs must be on lead or crated unless running.
- A fine will be assessed for any loose dog on the field not competing, or an exhibitor caught not picking up after their dog.
- You are responsible for controlling your dog(s) and children.
- •The Hunt master is responsible for field safety and therefore he/she is in complete charge of all dogs and handlers on the field. He/She has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve the dog on the course.
- Persons exhibiting conduct detrimental to the AKC/BCDC/ dog(s) or person(s) will be asked to leave the trial site by the Field Committee, maybe disciplined by the AKC, and **entry fees will not be refunded**.


